REGULATION 14 CONSULTATION RESPONSE FORM

This is the formal consultation on the draft Neighbourhood Plan for the Parish of Kingston. The Plan will include a number of policies that will become part of the planning process for Kingston and have similar status to the Plymouth and South West Devon Joint Local Plan, extending to 2034.
